    - Yes, when conducting drills the staff is notified.
  - Does your trauma protocol include instructions for pediatric patients?
    - At this time, we do not receive the pediatric trauma patients.
  - How do you handle the media during an emergent situation?
    - Security is notified of the "location" for media to be onsite
    - Hospital Communication Center has a prepared message to provide to the media

### Dallas Police Ambush: Transfusion Service Response; Pat Williams, BS, MT(ASCP), SBB, Manager, Transfusion Service, Baylor University Medical Center

  - Were the runners (delivering trauma packs to ER and OR) all blood bank employees?
    - No, we had help from volunteers in other hospital departments.
  - Would freeze dried plasma be a product that would be considered should it be made available in the U.S.?
    - Definitely would be helpful in these situations.
  - Did you run out of coolers that were used during the incident?
    - No, but that is something that we have to consider and plan for in the future.

### Massive Transfusion and the Role of Plasma Component: Thawed Plasma vs Liquid Plasma, Beatrice LeBeuf, MS, MLS(ASCP) SBB, Transfusion Service Manager, The Medical Center of Plano

- Attendee Questions/Comments
  - Do you have to keep the product segregated from thawed plasma in order for it to not be used inappropriately?
    - Policies were revised, thus, employees are expected to recognize when liquid plasma can be used.
  - Was there education/training needed to allow the use of liquid plasma?
    - Data was provided to physicians to gain approval to use liquid plasma.
    - There was lots of training done with the nurses and EMS.
  - Who is responsible for the temperature monitoring of the units provided to helicopter?
    - Temperature monitor is adhered to each unit we use Safe-T-Vue
    - Coolers are validated to maintain temperature at 1-10° C for 24 hours.
  - How many products do you keep on-site?
    - Keep a total of 8 liquid plasma 2 AB and 6 A
    - Use a total of 40-50 products per month
