Grant Funding Opportunities Analysis for Blood Centers Available to ABC Members

America's Blood Centers (ABC) is providing a new resource to member blood centers. The Grant Funding Opportunities Analysis is tailored for ABC member centers and was commissioned by ABC to identify targeted federal grant programs for which ABC member centers may be eligible to apply.

The final Grant Funding Opportunities Analysis is available to ABC member blood centers in MCN 22-042. This comprehensive document contains:

- an overview of grants including searching and competing for grants, grant compliance and lifecycle considerations, and best practices;
- a review of specific grant programs. The identified programs were included based on the type of projects blood centers may be undertaking and the fact that blood centers may be eligible for funding under these grant programs;
- and resources about where to look for grants and how to navigate the Grants.gov website (which must be used for federal grant applications).

This Grant Funding Opportunities Analysis was completed exclusively for the benefit of ABC member centers and should not be shared outside of ABC membership. Please provide any feedback, questions, or concerns, to ABC Senior Director of Federal Affairs Diane Calmus, JD.

At the ABC Annual Meeting in March 2022, a one-day Advocacy Workshop took place that included a session on federal funding opportunities, both grants and earmarks. Attendees received an overview on federal grants and discussions took place to gather information, which laid the foundation for this report to meet the specific needs of independent community blood centers.

This week, the U.S. Food and Drug Administration's (FDA) Center for Biologics Evaluation and Research (CBER) has published an updated guidance agenda for 2022. The agenda outlines the guidance and draft guidance documents that CBER "is considering for development" throughout the calendar year. The agency added two topics that were not included in the January announcement of the agenda:

- "Recommendations to Reduce the Possible Risk of Transmission of Creutzfeldt-Jakob Disease and Variant Creutzfeldt-Jakob Disease by Blood and Blood Components; Guidance for Industry; [and]
- Recommendations to Reduce the Risk of Transfusion-Transmitted Malaria; Guidance for Industry."

Other topics of note that the agency intends to address that remain from the earlier announcement include:

- "Blood Pressure and Pulse Donor Eligibility Requirements; Compliance Policy Draft Guidance for Industry;
- Alternative Procedures for Cold-Stored Platelets Intended for Transfusion Draft Guidance for Industry;
- Collection of Platelets by Automated Methods; Guidance for Industry;
- Compliance Policy Regarding Blood and Blood Component Donation Suitability, Donor Eligibility and Source Plasma Quarantine Hold Requirements; Draft Guidance for Industry; [and]
- An Acceptable Circular of Information for the Use of Human Blood and Blood Components: Guidance for Industry."

The topics listed for tissue and advanced therapies included:

- "Regulation of Human Cells, Tissues, and Cellular and Tissue-Based Products (HCT/Ps) Small Entity Compliance Guide; Guidance for Industry; [and]
- Recommendations for Determining Eligibility of Donors of Human Cells, Tissues, and Cellular and Tissue-Based Products (HCT/Ps); Draft Guidance for Industry; [and]
- Manufacturing Changes and Comparability for Human Cellular and Gene Therapy Products; Draft Guidance for Industry."

Platelet Transfusion and Outcomes after Massive Transfusion Protocol Activation. A study published in Anesthesia and Analgesia emphasized that a hospital's "laboratory can return an emergency hemorrhage panel of conventional coagulation tests within 15 minutes." The authors noted that [this] study aimed to describe early (first 4 hours) platelet transfusion practice in massively transfused (MT), severely injured trauma patients and to assess any association between early platelet transfusion and in-hospital mortality." The "hypothesis was that platelet transfusion in resuscitation of severe trauma can be guided by rapid turnaround platelet counts without excess mortality." Included were "all trauma patients aged ≥15 years admitted between October 1, 2016 and September 30, 2018 who had been triaged to a trauma team activation, suggesting life-threatening injury...[The] massive transfusion protocol (MTP) response include[d] transport of six units of red blood cells (RBCs), six units of thawed or never-frozen liquid plasma, and a unit of apheresis platelets to the bedside in <5 minutes in a portable blood transporter...Blood product use for 469 patients met the definitions of MT, and these patients were included in [the] final study cohort. The authors observed that, "[r]eceiving platelets in the 1st 4 hours was strongly positively associated (all P values ≤.001) with increased Injury Severity Scores (ISS), shock index, base deficit, blood lactate concentration, and international normalization ratio (INR), and strongly negatively associated with admission blood pH, hemoglobin, and platelet count (all P values <.001)...Overall blood product use differed markedly between early platelet recipients and later/nonrecipients, most early platelet recipients (175 of 250, 70 percent) received their first platelet transfusion in the first hour of care...Among the 219 patients who did not receive platelets in the first 4 hours, 46 (21 percent) received 5 or more units of RBCs in the first 4 hours." The study "saw no difference in 4-hour (8 vs 7.8 percent; P = 0.4), 24-hour (16.4 vs 10.5 percent; P = 0.06), or in-hospital mortality (30.4 vs 23.7 percent; P = 0.1) between platelet recipients and nonrecipients." The authors concluded that "early platelet transfusion guided by protocol-based clinical judgment and rapid-turnaround platelet counts was not associated with increased mortality."

WORD IN WASHINGTON

The House Energy and Commerce Committee has drafted the U.S. Food and Drug Administration (FDA) user fee legislative package. According to AgencyIQ, "Section 802 of the bill contains language that "would streamline FDA requests for feedback on blood donation. Under this provision, Congress would exempt the FDA's solicitations for 'views and perspectives of patients' on blood donation policies from the Paperwork Reduction Act requirements for information collection. Overall, this would lessen the burden for regulators seeking information that would 'support the development of recommendations' about blood donation. The FDA is currently looking at alternatives to the time-based deferral system for blood donation eligibility – although research in that area was delayed by the Covid-19 pandemic."

The Office of the Assistant Secretary for Planning and Evaluation (ASPE) in the U.S. Department of Health and Human Services (HHS) has <u>published</u> a report titled "<u>Impact of the COVID-19 Pandemic</u> on the Hospital and Outpatient Clinician Workforce: Challenges and Policy Responses." According to a news release announcing the report, the publication "combines a survey of the literature and primary analysis of data from the Census Bureau, Bureau of Labor Statistics, and other sources, with a focus on the hospital and outpatient clinician workforce, in order to describe workforce shortages both prior to and during the pandemic, COVID-19 impacts on the mental and physical health of the health care workforce, and an overview of federal interventions and investments to support the health care workforce during the pandemic." Topics addressed in the report include:

- healthcare workforce shortages and maldistribution;
- healthcare workforce burnout and mental health;
- healthcare workforce physical health;
- federal efforts to support health care workforce during the pandemic; and
- future opportunities moving forward for the health care workforce.

Kaufman Hall has <u>released</u> a "Special Workforce Edition" of its "<u>National Hospital Flash Report:</u> <u>The Financial Effects of Hospital Workforce Dislocation</u>." The report describes how the pandemic exacerbated a national shortage of healthcare workers and increased expenses for hospitals. Findings of the report include:

- nationally, hospital labor expenses increased by more than one-third from pre-pandemic levels;
- the largest increases were in the South and West, while the highest expense levels consistently were in the West and Northeast/Mid-Atlantic;
- contract labor as a percentage of total labor expenses increased more than five times the rate from pre-pandemic levels;
- as of March 2022, the median wage rate for contract nurses had risen to more than three times that of employed nurses; and
- in the first three months of 2022, hospitals saw dramatic declines in YTD operating margin in a perfect storm of expense, volume, and revenue pressures attributable largely to the effects of COVID.

Héma-Québec has <u>reported</u> its findings from the fourth phase of a seroprevalence study of blood donors that estimates "more than one in four Québec adults developed antibodies to COVID-19 due to infection" in the first quarter of 2022. A news release explaining the findings stated, the "analyses were done with tests able to identify antibodies present in people recently infected by SARS-CoV-2. The approach compares the level of antibodies in the same individual, based on two samples taken at different times. A first sample was collected prior to the arrival of the Omicron variant of concern and another was collected from the same person in 2022, once the Omicron wave was well underway. Using plasma donated to the PLASCOV project, this study estimated that 27.8 percent of the adult Québec population had contracted COVID-19 between the end of 2021 and March 2022."

ImpactLife recently welcomed Bob Barnes of Syracuse, N.Y. who is in the process of biking crosscountry to visit all 50 state capitols over 12 months to raise awareness for blood donation. Mr. Barnes donated platelets at an ImpactLife donor center in Cedar Rapids, Iowa on May 11th and intends to donate again with ImpactLife in Madison, Wis. as he is more than 12,000 miles through his journey. "I don't have a lot of means financially, and blood is something I can give and anybody who is eligible should give because I think it's the human thing to do," said Mr. Barnes to The Gazette. According to the publication, Mr. Barnes "started the trip Aug. 1 last year, and plans to make it to Juneau, Alaska, by Aug. 1, then fly to Hawaii. After pedaling from the airport to the state capitol, Barnes said he plans to

spend some time in Hawaii as a reward for the yearlong endeavor."

The Lithuanian Health Ministry has <u>revised</u> its donor history questionairre for blood donors. According to a report in *The Baltic Times*, all individuals who present to donate blood will be asked "the same question about unprotected sexual relations they have had in the last six months" as a question asking men about sexual contact with other men was removed as of May 1st. "By making it possible for [gay and bisexual men] to become blood donors, Lithuania is coming out of the fear and closed-mindedness," said Tomas Vytautas Raskevicius, a Lithuanian lawmaker. "A person's ability to become a blood donor is not determined by their sexual orientation but by their behavior and health."

Terumo Blood and Cell Technologies has been awarded a \$10.6 million contract to continue its works on freeze-dried plasma, which "can be kept at room temperature and is ready in minutes after reconstituting it with medical-grade water." According to a company news release, the contract partners Terumo Blood and Cell Technologies with the Medical Technology Enterprise Consortium (MTEC), a 501(c)(3) "biomedical technology consortium collaborating under an Other Transaction Agreement (OTA) with the U.S. Army Medical Research and Development Command, and is sponsored by the Defense Health Agency (DHA) and managed by the Naval Medical Research Center (NMRC) to drive healthcare advances for the battlefield." Terumo Blood and Cell anticipates using the funds to further "product development" as it prepares for future "clinical studies and continued verification testing." Currently, the company is developing bags that resemble standard blood bags to reconstitute the freeze-dried powder quickly." Chetan Makam, general manager of Global Blood Solutions at Terumo Blood and Cell Technologies added in the news release, "[y]ou can only imagine that it's nearly impossible to carry a giant freezer with frozen plasma into a conflict or trauma zone. And at home many hospitals outside major urban settings do not have plasma readily available because of the logistics of managing it. We envision a day when clinicians can use our freeze-dried, shelf-stable plasma to provide the same level of therapy for severe bleeding no matter where it happens whether it's on a battlefield or a remote highway, in a midsize hospital or at a top-tier academic medical center."

Grifols recently finalized the <u>acquisition</u> of **Biotest AG**, a European healthcare company specializing in innovative hematology and clinical immunology. A news release announcing the acquisition stated the transaction "expands and diversifies" Grifols' plasma supply, while allowing the companies "to jointly increase the global availability of plasma-derived therapies." The acquisition also adds 29 Biotest plasma centers under Grifols' umbrella of plasma centers making it the largest private European network of plasma centers.
